Alpine Dog Kennels Boarding Policies

Please read an initial each section

1. _____ Owner agrees that the pet shall not leave the kennel until all of the charges are paid in full to Alpine Kennels.
2. _____ Owner agrees to be responsible for any and all acts or behavior of the Owner's pet while in the care of Alpine Kennels.
3. _____ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, Alpine Kennels may exercise its lawful rights upon ten (10) days written notice by delivering such notice via first-class mail to Owner's Address. A pet(s) that is unclaimed at Alpine Kennels for ten (10) days beyond its scheduled discharge date is considered abandoned and will become the property of Alpine Kennels. Every effort will be made to contact Owner if abandonment becomes an issue. If for any reason the pet(s) is not going to be picked up on the scheduled dismissal date, Owner shall contact Alpine Kennels to make arrangements to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.
4. _____ If the pet(s) becomes ill or if the state of the animal's health otherwise requires attention, Alpine Kennels at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$500.00 or _____, whichever is greater. If a veterinarian determines that emergency treatment, which Exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal(s).
5. _____ It is expressly agreed by Owner and Alpine Kennels that Alpine Kennels liability in no event exceeds the lesser of the current chattel value of a pet(s) of the same species or the sum of \$200.00, whichever is less.
6. _____ Owner agrees to release, indemnify, and hold harmless Alpine Kennels from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Alpine Kennels' services, except which may arise from the gross negligence or intentional and willful misconduct of Alpine Kennels, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Alpine Kennels (ii) your dog(s), including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.
7. _____ This Agreement shall be governed by and construed in accordance with the laws of the State of New York. Each party consents to the exclusive personal jurisdiction of the state and federal courts of the State of New York. Owner and Alpine Kennels must negotiate and mediate in good faith prior to either party filing a cause of action
